# Canton cops, FBI foil robbers' deadly pact

A deadly pact between two men who are suspected of robbing the Standard Federal Bank in Canton on Sept. 14 was foiled when Canton police apprehended them last Wednesday, shortly after the pair allegedly robbed a bank in Livonia.

The plan, revealed by the men in an interview with Canton police, was to kill everyone in the bank, including police, if they were surrounded and felt they would be caught.

Canton police, who worked with the FBI on the case, received notice at noon on Wednesday from the Livonia Police Department that a robbery just occurred at a bank on Plymouth Road.

The description of the suspects appeared to match that of the bank robbery in Canton.

Detective Laura Golles said Canton's

dispatchers alertly recognized the correlation and advised the detective bureau and road patrol, who immediately set up surveillance in and around the Canton residence of one of the suspects.

At approximately 12:30 p.m., the suspects pulled into the parking lot of the Franklin-Palmer Apartment Complex, observed the officers and fled on foot.

One suspect was apprehended in the laundry room of a building and the other a few buildings away.

No one was injured in either bank robbery or the capture of the suspects.

The suspects are 23-year-old William Faison of Canton and an unidentified 16year-old, also of Canton.

Canton Detective Jerry Hardesty said Canton has not brought charges against the two, but said prosecutors are looking

# **Woman found dead** in Hines Park Friday

The fun ended early for a group of Frisbee players late Friday when they discovered the body of a 39-year-old Detroit woman in the Rouge River in Hines Park.

According to Wayne County Sheriff Chief of Staff Nancy Meridian, physical evidence on the victim's person have led investigators to believe that Mary Busby was beaten and strangled. Meridian said that information has been confirmed by the medical examiner, who is still trying to determine if she was raped or drugs were in involved.

"She had bruises on her body which indicates she could have been beaten," Meridian said.

"She also had burn marks around her

Meridian said investigators believe she

was raped prior to the strangulation, due to the marks. She also said Busby's body was discovered with her sweatpants and underwear down to her knees.

She said detectives are currently investigating tips on possible suspects.

Busby's body was positively identified by her husband — who described his wife to authorities as a crack cocaine addict and prostitute — on Sunday.

Meridian said preliminary investigations indicate Busby was murdered elsewhere and her body brought to the park, between Edward Hines Drive and M-14. Investigators are yet to determine where the homicide may have taken place.

According to police reports, a group of teenagers were playing Frisbee late Friday when they found Busby in the Springbrook picnic area.

## Schools reject master plan offer with municipalities



# Voters briefed on library millage

Approximately 30 people turned out Wednesday for a forum on the Nov.8 general election millage proposal geared to raise \$7.3 million in bonds to construct and operate a new library facility in downtown Plymouth.

The meeting, attended by residents and library officials, had a positive and informative setting, according to Library Campaign Committee member Nan Cooper.

"People were very positive, it was a very pleasant atmosphere," she said.

Cooper said members of the audience had questions ranging from cost to construction time to parking.

"Everyone had their own questions and their own way of asking," she said. "People were more involved with why the new library was needed."

Architect Mark McPherson was available to answer questions and address concerns regarding how the library will look and what effect the renovation will have on the community.

He said the library will retain its facade on Main Street, maintaining its original look. McPherson said it is important to keep that appearance.

"People become used to a familiarity," he said.

McPherson said other changes include the realignment of Church Street, with some possible parcel purchases of existing properties near Church and Union streets. He said that realignment will be needed to offer better parking for library patrons.

"With the expansion, the realignment will be necessary to accommodate parking," he said.

Voters will be asked to approve a separate bond issue and millage proposal to expand the library's square footage from 12,000 to 48,000.

According to Library Director Pat Thomas, it was space constraints which led to the need for a larger facility. She said the summer reading program alone involves 400 children.

"Some people have said there is no longer a quiet space in the library," she said. "The extra space will be used for reader space because we are so out of balance now."

If the millage increases pass, Thomas said construction could begin in spring of 1995. It is expected to last 18 months.

If either one of the measures do not pass, Cooper said the project will be put on.

"If both millages do not pass, we will not go ahead with it," Cooper said. "There are too many cities with nice libraries and not enough money to operate them."

Little said that he was glad that the proposal was tabled, stating that the schools should have some idea of what they would like to do with the park before stepping in and paying for a master plan.

"We need to have a sense of what we want to do with the park before going further," Little said.

# Sub residents angry over road extension

The Canton Board of Trustees found out last week that they cannot please all the people all the time.

More than a dozen residents of the Hampton Court subdivisions showed up at the board meeting to stop the extension of Charrington Drive to Warren Ave., but to the chagrin of the residents, the board found its hands were tied and unanimously passed the final site plan for Rolling Ridge Condominium development.

The controversy stemmed from the plans for the area, a nine acre, 27-site development slated for construction on a site between Warren and Sheldon Center.

The plans show an extension of Charrington Drive, which would connect Warren and Sheldon Center, making the road a shortcut — and, residents of the

subdivision said, increasing traffic.


Subdivision resident Jan Novak summed up the feelings of the people living in the area.

"This is a clear-cut example of inept planning right from the start," she said. "The residents feel completely disgusted.

"Mr. Bennett, in your campaign literature you call for less government and more common sense. We want that right now.

"We want to know why the developers are calling the shots here."

Board member Loren Bennett said he wanted to see some type of compromise between the residents and Ron Cook, the builder

### Garland hired by Detroit Archdiocese to run Mission Hills

The famed Garland Golf Resort of Gaylord is branching out to Plymouth Township — to the delight of local golfers.

Under a year-to-year management contract, Garland has been hired by the Archdiocese of Detroit to run Mission Hills Golf Course on Sheldon Road surrounding the currently-empty St. John's Seminary.

"We're very excited about this opportunity," said Barry Owens, the general manager of Garland who also happens to be a 1979 graduate of Salem High School.

"Garland is well respected for its golfing and resort

Operations.

Owens said Garland has openly been negotiating with the Archdiocese for a development in Clarkston, but the Mission Hills opportunity came up first when the existing lease with an operator expired.

"Economic reasons" attracted the Archdiocese to the Garland as a manager, said Owens.

He said previous problems at Mission Hills had not been mentioned in negotiations with Garland.

On Aug. 12, 1992, the Archdiocese was embarrassed when Plymouth Township Police raided the golf course owned by the church and operated by the former lessee. In that incident, a topless bar's golf outing was broken up

and three women were ticketed for indecent exposure.

During that "raid," a man from the topless bar was charged with assault after he attempted to take the film from the camera of Crier Photographer Rachael Rozmys. That charge was later dropped.

Since then, the Archdiocese has taken St. John's Seminary off the real estate market, saying it would keep the facility and develop it as a "family center."

Sale of the seminary is currently contested in court, but the Archdiocese says its going ahead with its plans.

"A lot more will become clearer in the next month or so," said Owens, of the Garland plans as they relate to the Archdiocese plans for St. John's.

to charge the 16-year-old as an adult.

Regardless of how the two are charged, Hardesty said all the law enforcement agencies involved worked well together.

"I definitely think all the Canton officers did a great job," he said, "including the dispatchers.

We worked well together and because of that, there are two bad people that are behind bars."

The search for the suspects began when the two allegedly robbed the Stand Federal Bank on Sept. 14, where an undisclosed amount of money was taken.

A man wearing a gas mask, baseball hat, surgical gloves and carrying a pistol got out of a beige Mercury Sable — earlier carjacked in Westland the same day — and entered the bank.

A Canton police report said that as the first man announced that he was robbing the bank, a second — wearing a t-shirt, gloves, gas mask and carrying a long-barreled rifle — seized the manager of the bank and forced two of the tellers to empty their cash drawers into a plastic garbage bag.

The suspects fled from the scene, but police found the gas mask on Elmhurst St. and the getaway car at the Bedford Square Apartments.

# Canton Township supervisor hospitalized

Canton Township Supervisor Tom Yack was hospitalized this week following what appeared to be a kidney stone attack.

While sitting in a meeting, Yack doubled over in pain.

With a history of kidney stones, Yack

knew what was happening.

though the builder has the right to do what he wants with the land.

Cook, who originally wanted a cul-desac at the end of Charrington Drive, said to comply with Canton ordinances and Wayne County recommendations, the road would be extended all the way to Warren.

Under a Canton ordinance, any subdivision with more than 20 units must be accessible by two separate points. The 24 units planned for Rolling Ridge make a cul-de-sac impossible under the ordinance.

Cook said he is willing to talk to the residents about future changes that could be made, but also noted the importance of getting the project underway.

"We only have the next 60 days to get started for this construction season," he said. "The road will go in this year. We have all the county, state and Michigan

# Canton High hosts math-science conference

New avenues in teaching math and science were the focus Saturday as teachers and educational experts from all over the state and nation converged on Canton High School for the Mathematics and Science Fall Conference.

The conference, sponsored by the Detroit Area Council of Teachers of Mathematics (DACTM) and the Metropolitan Detroit Science Teachers Association (MDSTA), has been at Canton High School for the past four years.

According to Ron Carlson, a mathematics and computers teacher at Canton High and a past-president of DACTM, the conference centered around new ways to teach math and science.

"There will be over 200 sessions involving workshops for math and science teachers," Carlson said before the conference. "Mostly discussions of new topics, and concepts in teaching."

Carlson said that teachers from all over southeastern Michigan, the Metro Detroit area and as far away as Alpena came to the conference.

"Textbook companies send vendors as well as companies that make educational technology and software," Carlson said. "This year the I.R.S. ran a mathematics booth."

Carlson said that last year 2,200 teachers came to the conference and — even though preregistration was slow this year — he got almost as many this year.

"Just a little less than 2,000 preregistered for the conference," Carlson said. "But we had about 500 people walk into the conference during the day."

"There were a lot of Plymouth-Canton teachers making presentations." As an added benefit of hosting the conference, the schools got \$1,000 for math and science scholarships.

"It's just common sense that traffic will go down Charrington."

Although several ideas on how the disagreement could be solved were presented to the board, none of them conformed to all Canton and Wayne County laws for roadways.

"If, later on, ordinances change," said Cook, "I would have no problem with that (making changes to the plans).

"But I don't want the responsibility or liability of closing off that road in the future. "Residents of each subdivision I have developed (nine in the Canton area) have voiced their opinions on these type of situations. I would feel uncomfortable about explaining to the other subs why their complaints weren't listened to."

Yack said with more time to discuss the situation, the controversy could be solved, but also that he did not want to delay Cook in the development of his land.

"If you could just sit in my chair for one week," he said. "If everyone who showed up here angry got their way, this would be a terrible place to live."

### Reverend starts new Episcopalian congregation in Canton

Amidst the housing growth in Canton, the Rev. Steve Rottgers noticed something missing. He realized with all the new homes and subdivisions, Canton seemed to be lacking places of worship to accommodate the new neighbors.

So he's starting a new one.

All Saints Church in Canton met for the first time last week in Tonda Elementary's cafeteria with 30 initial members.


In picking a location to establish the Episcopalian church, Rottgers did his homework.

He said the plan called for choosing and finding an area with potential for growth. Rottgers said he examined Canton's demographics and rate of development, seeking to add a source of faith to the community.

"It is similar to starting a business," he said. "You need the wisdom of marketing and advertising and a tremendous amount of faith."

Rottgers has been operating out of office space in Canton Ford Crossing on Canton Center Road since July. He said members gathered for the first time and named the church.

From there, Rottgers said the parish will celebrate a Sunday service and

intends to also gather individual groups during the week for prayer and bible study. He said he believes the method, practiced for centuries, will fill a void in society.

"Today there is no large, extended family support network," he said.

All Saints is a part of the Episcopal Diocese of Michigan, which owns seven acres of land on Warren Road, midway between Beck and Ridge roads.

According to Rottgers there is no specific time schedule for when the structure will be built.

He said the congregation will know when the time is right to move from the school to a new facility.

"It will happen as it happens," he said. "It could be a year or two years. There will be a sense of discernment and we'll say 'okay, let's build."

Rottgers said when that time comes, it will provide parishioners with an opportunity to help in the physical creation of the structure.

Church members will assist in the planning and developing of what the church looks like.

"They will decide what it looks like," he said. "It will be a great opportunity for people who are creative."

All Saints is the fourth church Rottgers said he has "birthed" and he relates the experience to that of rearing a child.

"It's like watching a child grow," he said. "You watch them take each step and you see the potential and hope for the future. It's a clean slate."

### Test helps students plan for their career

Those who fail to plan, plan to fail.

To better prepare students for their further education and their eventual careers, some students in the high schools are being given the chance to track their skills and make plans for the future.

10th graders in the Plymouth-Canton schools will be able to get an early idea of where their strengths lay this month by taking the PLAN test.

The test, which was created by American College Testing (makers of the ACT college entrance test) in Iowa City, IA, was designed to give students a guide to plan their remaining high school years

and college and career beyond.

According to Canton High School Counselor John Seidelman, the PLAN test incorporates rating academic prowess with career goals.

"The PLAN test has all of the same components as the ACT test, same conditions and subjects," Seidelman said. "But it also has career and interest components."

Seidelman also said that the test, while like a pre-ACT that is geared to 10th graders, is not a tool used by colleges when considering whether or not to enroll a student. Performing poorly on the academic portions of the PLAN test has no

"Part of the test is self-assesment and an inventory of interests and experience," Seidelman said.

According to Seidelman, in the last five years an average of 200 to 225 students (roughly 40 to 45 per cent of those eligible for the PLAN) at Canton High have taken the test.

A graduate of Plymouth High School




The team lost last years number one singles player, Ellen Gaston to graduation. Her shoes have been filled by junior Nikki Rohnert.

# Turnovers key in Rock victory over N. Farmington at home Saturday

The Salem Rocks found success on the road as they rolled over the the Raiders of North Farmington, 28-8 with a hard hitting ground attack.

The Rocks capitalized on two first half turnovers by the Raiders, while not turning the ball over themselves, going up 14-0 at halftime.

Quarterback Brad Lear kept the attack on the ground, only completing one for seven for seventeen yards.

Salem's running backs were the highlight Saturday, rolling up 263 yards and scoring all four Rock touchdowns. Tailback Mike Brannan was outstanding, posting 153 yards on 27 carries, and scoring two touchdowns. Fellow back Kevin Grim scored a touchdown on a crushing four yard dive, the big fullback had 51 yards on 15 carries. Tailback Ryan Hoffman scored the final touchdown from three yards out.

Turnovers were the key to the game as North Farmington continued to hand the ball over in the second half, while Salem remained sure-handed finishing the game without giving away possession.

"We won the turnover battle out there," said coach Tom

Moshimer. "That's how you win games."

The Rocks kept North Farmington pinned most of the game, resulting in six Salem drives that started in Raider territory. The defense kept Raider quarterbacks Mark Lee and Russel Hayes scrambling, holding them to a combined six for fifteen passing, while stuffing their running game, holding them to sixty nine yards on the ground.

Strong safety Ashraf Yousef had an excellent game breaking up pass plays and generally sticking the few Raider backs who found themselves in the Salem defensive back field. Dan McKian also participated in the defensive swarm picking off a Mark Lee pass, setting up Salem's first touchdown. Cornerback and back-up QB Dirk Schmeidel got into the action with a fourth quarter interception resulting in yet another Rock touchdown.

Losing 28-0 late in the fourth quarter North Farmington scored on a forty eight yard bomb with less than a minute to go, reminiscent of a certain Colorado University desperation hail Mary. They then scored a two point conversion on a quarterback keeper. Final score: Plymouth Salem Rocks- 28, North Farmington Raiders- 8.

### Steelers beat Belleville 24-6, 18-0


On Sunday, the Canton Steeler freshman and J. V. squads crushed the Belleville Cougars, winning 24-6 and 18-0, respectively.

That tax rollback was the best news delivered to his hospital bed second only to the 400-pound pumpkin inscribed to (his wife) "Florence and Roger" and delivered by his brother Duane and friends. (One of Roger's happiest recent moments was the horse and buggy ride last year for their 50th wedding anniversary. How he beamed in that photo!)

True to the old way of rural life, the family of farmers held a "harvest funeral"

yesterday for Roger. Cornstalks and pumpkins decorated the casket area. The scene left the lasting impression that, once more, farming was disappearing from The Plymouth-Canton Community.

•Blesseds don't sell strawberries on Powell Road.

 Dick Kirchgatter sold his combine and now hires the Wilkins to harvest his field.

•The huge Palmer barn — site of pickup basketball by cornpicking Plymouth High School athletes — is gone.

•Subdivisions sprout where the Brinks Farm Market once offered nature's goodness grown there.

•Plymouth Grange, once one of the state's most prestigious chapters, is winding down since the hall is "gone" and Fall-Fest-Apple-Pie-Maker Helen Eckles just passed on.

## Students must adhere to simple code of social conduct

I am writing this in response to your recent editorial with regards to school expulsion. Unfortunately, your article appears to give the impression that students are removed from the school setting without regard for their well being. You imply that the youth is a victim of the system.

Your belief that youth are victims is what perpetuates the non-accountability that youth have been led to accept. In doing so, youth are given the perception that they are not responsible for their behaviors or impaired thinking and furthermore the consequences which result are either unjust or unfair. Adhering to a very simple code of social conduct or a series of behavior expectations within the school environment is not a difficult task. A majority seem to be able to handle it without many complications.

I am confident that when a student has reached the point of expulsion, many hours and a great deal of creative effort have gone into helping the youth make positive behavior changes. However, I am sure that somewhere during this process, the youth make a conscious decision to be expelled. I do not believe that administrators feel that expulsions are the "cathartic dose of reality" as you put it, but merely the end result of a series of steps

in a due process procedure. You mention that you know many friends who have been expelled. I would challenge you to ask them how their negative behaviors or attitude played a role in their expulsion.

In addition, you imply that sending a youth to Maxey Boys is like sending a child to camp. Believe me, this is not the case. Again, youths who are placed in a state facility, go through a series of lengthy and costly interventions as well. These youth have also made a conscious decision not to participate. There are many frustrated parents and police agencies who deal with incorrigible youth who would tell you that getting legal intervention is next to impossible unless the youth has committed a heinous crime.

I agree that as a community we need to work together to find education alternatives. I do not think that you will find many educators that see expulsions as a positive action, but when a youth chooses to act in an unacceptable or inappropriate way, expulsion becomes a necessary tool. Do students deserve a second chance, absolutely, but responsibility for changing negative behaviors and attitudes falls upon the youth, not the educational system.
