

City decides fate of Mayflower tax bill Monday

The Plymouth City Commissioners are damned if they do, damned if they don't...

Should they give the Mayflower Hotel a \$50,456 tax gift on top of the significant rollbacks the hotel properties have already enjoyed?

What if the City Commissioners don't give in and the hotel goes bankrupt or closes, blaming that decision? What would be the impact of a closed hotel on downtown?

A number of Plymouth-Canton residents and businesspeople have raised questions about the proposed tax break.

Although the new owners of the Mayflower took over July 14, 1994 — two years ago they have yet to pay a single dollar in property or personal taxes to the City or a single water bill, say City officials.

Nor have the new Mayflower owners supplied the City with an accounting of the hotel's personal property declaration even though they are begging relief, says City Hall. (Previous years' declarations were not received after the late Ralph Lorenz died.)

Matt Karmo, co-owner of the hotel, said he believed a tax payment of about \$67,000 was made to Wayne County last year to avoid a tax sale. "We had to avoid that," he said, although he was uncertain of the exact amount or circumstances of the payment.

Still, the City Commissioners are considering the \$50,456 tax break to be awarded at the next City Commission meeting on Monday, Aug. 5 at 7:00 p.m. in City Hall.

A number of citizens attended the scheduled Mayflower tax break vote at the City Commission meeting July 15, but the item was removed from the agenda when City Attorney Donald Morgan and City Manager Steve Walters said all details were not complete.

The hotel's owners say the tax break is critical in their new financing plan that would help the property recover and redecorate from its previously-Lorenz-Family-owned days of bankruptcy. "We're asking not to waive taxes but to waive penalty and interest that was accu-

Teachers angry over slow progress in contract talks

If contract negotiations aren't completed before the beginning of the school year, teaching situations and conditions will be affected, Plymouth-Canton School district teachers said at Monday night's school board meeting.

A vocal group of approximately 30 teachers and their supporters expressed displeasure with the progress of contract talks, initiated in February, and petitioned the P-C School Board and school district negotiators to finalize issues before students return to school next month. "Without a contract, a lot of energy I see is, what I consider, very negative and counter-productive time spent," said Plymouth-Canton Educational Park teacher Jerry Thompson.

"I think it's extremely important," said Mike Chiumento, a West Middle School teacher, "that when Aug. 26 comes around, that we be in place."

"I urge the board and its bargaining unit to make this a priority," said Judith Ray, also a West Middle School teacher.

Primarily at stake, insiders said, is health insurance. Beverly Winkelmann, a teacher at East Middle School, said she heard the Blue Cross/Blue Shield coverage might be a "stumbling block" in negotiations. "I would like you to show


"If the hotel does not recover financially, it is not certain that the City could ultimately collect all the delinquent taxes and interest which are currently due," Walters wrote the City Commissioners.

Walters' proposal on the Mayflower tax break stresses several times that the hotel would remain functioning as a hotel and restaurant operation.

The City tax break under consideration would be on top of:

- A reduction in the hotel's real property taxes for 1993, 1994 and 1995 of \$142,081;
- an original 12-year tax abatement on the Mayflower II project (the additions built over

City, Twp. hope to save by sharing recreation services

Officials from the City and Township of Plymouth met last week to once again discuss the hotly-debated topic of shared recreation services.

At the July 16 meeting of the Township Board of Trustees, Supervisor Kathleen Keen-McCarthy reviewed the progress of the July 15 conference with City Mayor Ron Loiselle, Commissioner Doug Miller, City Manager Steve Walters, Township Finance Director Rosemary Harvey and Township trustees Ron Griffith and Charles Curmi.

McCarthy said it was agreed that the Plymouth community recreation program should be coordinated with other recreation providers, such as the Plymouth YMCA, to avoid duplication of efforts and to maximize the recreation benefits from available resources. "Everybody offers recreation and we really don't check with each other," the supervisor said.

Also, it was decided, a survey will be conducted of the recreation facilities and programs available from both public and private agencies. "We don't have a good sense of community needs for recreation," McCarthy said, "so we're going to check into having a survey done."

The meeting was the second this month between the two municipalities and both sides agreed discussion has been cooperative. "I thought it was a very positive meeting," said Griffith. "No one was there to throw spears."

That attitude hasn't always been present. during discussions of joint services between the City and the Township.

While the Plymouths succeeded in combining the fire departments in 1994, an effort to cooperatively purchase voting equipment went awry last winter — leaving some City commissioners angered with Township trustees. And little progress has been made concerning joint emergency dispatch. The recreation talks haven't been without controversy, either. Walters wrote a letter threatening to revoke recreation services from other communities' residents a move that irked Griffith.

But both sides are holding out hope for better results this time. Earlier this month, Miller, an outspoken critic of the the voting machine fiasco, said, "I think the Township is sincerely willing to work with us on (the government's role in joint recreation services.)"

Another meeting is scheduled within the next two weeks, McCarthy said.

Trustee Kay Arnold asked if Schoolcraft College and the Plymouth-Canton Schools would be invited to partic-

"I think that would be a good idea," said Clerk Marilyn Massengill.

us, in good faith, some proposals that will help us continue this coverage," she said.

What bothers teachers is the pace of the mediation meetings. "My concern is negotiations began in February and I don't see negotiations being any farther along then when they were done in

P-C School Board President Mark Horvath said board members and administrators could not comment on the contract issues, but he maintained they are anxious for a settlement as well. He said: "There is nobody in this room more than the people up here who want this settled.

Community leaders missed election

The pillar of democracy: one person,

It started a revolution 220 years ago. People have been fighting and dying for it ever since.

Bus the passion for the right to choose has faded. Freedom's voice has fallen on deaf ears at national, state and local elections. The public's lack of interest has never been as painfully obvious as the June 10 Plymouth-Canton School Board election.

Without a money issue on the ballot, 2.87 per cent of the total registered voters made it to the polls. More than 60,000 Americans would not or could not use the right given to them by this country's

Included in that vast majority are several elected officials who directly benefit-

ed from that very action. And several school administrators who are directly affected by the outcome.

The reasons and excuses for not voting were many. The struggle with their "no-choice" was evident. But the solutions to the apathy epidemic were few.

From trustees to commissioners to principals, these community leaders spoke candidly. They said the evolving lifestyles and workforce were to blame for the low turnout at the polls, along

"Five times I was headed to vote, and I got paged," said Plymouth Township Trustee K.C. Mueller, who is a real estate agent. "Unfortunately, I got paged. And time is of the essence in real estate.'

A busy work schedule also prevented Canton Trustee John Burdziak and George Belvitch, a principal in the P-C School District, from voting. "I missed voting on June 10," said Belyitch, who is active on a voluntary basis for the school district, including the Housing and Facilities Committee. "Thinking back to June 10, boy, I was busy at work, busy at school. I just forgot. It was the first community school election I've missed. I pretty much vote in every election.'

Burdziak said a last minute business trip was the reason he didn't make it to the polls. "I was out of town. I didn't make it back in time," he said.

Plymouth Township Trustee and Schoolcraft College employee Ron Griffith claimed the same fate. "I just blew it. It's the first election I missed in, God, I don't know how long," he said.

Griffith said he may have paid more attention to the election if the candidates had run high-profile campaigns. "I never really got anything in the mail from those candidates," he said.

Farrand Elementary School Principal Ann Kuhn missed too. "I was out of town and I forgot to get an absentee ballot. That's terrible," she said. "I have made every other election."

So what made this election so unimportant to Kuhn? "I think what you might hear is the slate wasn't much to choose from," she said, adding that unlike previous elections, candidates didn't visit her school. "(P-C School Board President) Mark Horvath, when he ran (in 1994), you really knew who he was.

Canton Supervisor Tom Yack knew who he was going to vote for, but he never cast his ballot. "I was in the hospital," said Yack. "That was my first miss in, I'd have to say, 20 years. I was in the hospital. What can I say? If I would've anticipated it, I would have gotten an absentee voter form."

Yack, a former school board president, called the number of ballots cast "pathetic." "When you see a number like that, the community really has turned it over to

Canton planning meetings to be broadcast

Plans to cablecast Canton's Planning Commission meetings have progressed on schedule. The commission's Aug. 12 meeting will be the first session taped for later broadcasting on Canton's government access channel (currently channel 15 on Continental Cablevision).

The meetings are likely to be aired on Tuesday, Thursday and Sunday evenings at 7 p.m.

The last two meetings were taped as practice. Municipal Services staff members reviewed the commission's July 1 meeting, assessing the quality of the broadcast and determining what, if any, format changes were needed to make the meetings more viewer-friendly.

A recent survey conducted by the Canton Chamber of Commerce's "Leadership Canton" group asked residents about their cable-viewing preferences. The survey, included in the FOCUS newsletter, will assist in the development of governmental programming that will support a wide range of community needs. Among the public meetings listed, Canton's Planning Commission meetings ranked number one for level of interest among those surveyed.

"We feel that broadcasting the planning commission meetings is a good step toward raising resident awareness," Canton Resource Development Director Mike Ager said. "Many people aren't able to attend the meetings in person. Broadcasting them on a regular basis makes them convenient and accessible to all."

Currently, the Canton Board of Trustees' regular sessions (two meetings) are taped each month and aired for broadcast. (Continental Cablevision currently tapes these sessions, but Canton personnel will assume this responsibility later this year.) The administration is considering taping and airing the board's

Plans are also being reviewed to install remote cameras and a sound room in the main meeting room for the taping of future

Tapes made of the commission meetings will not be edited prior to broadcasting.

Study projects 1,000 new students in next 5 years

An enrollment study report and projection, critical in a schedule leading to an anticipated winter bond vote, was presented and discussed at Monday night's Plymouth-Canton School Board meeting.

Data provided by Stanfred Consultants predicted the P-C School District will increase by at least 1,000 students in the next five years. "Something in the neighborhood of 1,000 students is what we're going to be experiencing by the year 2000," said David Rodwell, the executive director of research and technology, who presented the report.

The projections reinforced the findings of the P-C Schools Housing and Facilities Committee and Southeast Michigan Council of Governments (SEMCOG) reports: The Plymouth-Canton Community is growing, and as a result, so

is the student population of the school district.

A report by the Housing and Facilities Committee, released this spring, said the P-C Schools might need as many as five new schools to accommodate incoming students. Superintendent Charles Little developed a growth management plan to put the school district on the track for a winter referendum, possibly as early as December, to attain the necessary funding for new schools.

Little said a survey conducted by the school district's Long Range Planning Committee, scheduled to be released today, indicates that residents are overwhelmingly in favor of spending more money to reduce class size. "It's quite clear that class size is the largest issue up

special interest groups. That could be positive special interest groups. I'm not trying to put a negative spin on it," he said.

Griffith said sometimes it's not in the best interest of candidates to have a high voter turnout so his or her support group has more voting power. Belvitch suggested a ballot that included just candidates with no millage or bond — was the reason for the lack of interest. "Whenever you have a major league issue, people come out all over the place," he said. "But they don't come out to vote for their school board candidates.'

Don't blame the candidates, said Paul Schrauben, a school board hopeful who voted and finished third in the election. "I was disappointed with the turnout," he said. "I hesitate to say it was because it wasn't publicized, or because of the candidates. I worked my butt off."

Schrauben said he mailed campaign literature and credited local newspapers and cable television for their coverage of the race. As a former election worker who watched parents stroll right by the polls to pick up their children, Schrauben said, "If people can walk right past it, what can you do?"

Getting to the polls was the problem for Griffith, Belvitch, Mueller, Burdziak and Kuhn. But the delinquents could only offer a few suggestions that may have helped them in their lost cause. The most popular proposal: moving school elections to coincide with other community elections. "I would've liked to have it put on the Aug. 6 ballot when you get more voters out," said Griffith.

Said Kuhn: "I think if it were in September, when people were going back to school and more interested, or even in the spring when people are thinking about pext year — sometime during the school year (turnout would've been higher.)"

Even though absentee ballots are now made available for wide-ranging excuses, they must be obtained weeks ahead of time - making them obsolete for residents with emergency business commitments. Mueller suggested having votingbooths at the workplace, especially larger facilities. Longer poll hours would help too, she said. And more accessible public forums are needed, said Kuhn. "Maybe forums in the elementary schools would help, and I say elementary because they're a lot closer to the neighborhoods, and they're a lot more comfortable," she said.

Until changes are made, the phenomena of voter apathy will likely continue and possibly even after that. "I struggle with it. I don't know what the answer is," said Griffith. "Maybe there isn't an answer... It's an important issue. Schools are critical to a well-rounded community. It's a problem and, unfortunately, this time I was part of the problem.'

But choosing not to choose is also part of being American.

City Mayor Ron Loiselle, Schoolcraft College Board of Trustee Mary Breen and Allen Elementary School Principal James Burt were not available to comment on this story.

Joe Van Esley has been preparing for this day for a decade.

And his persistent searching and browsing at antique shows and shops has paid off with a classic collection of Americana inside American Pie Ice Cream Parlor, 747 W. Ann Arbor Trail.


The old wood floors, posters of folk heroes, pictures of presidents you love to love and hate, an old soda pop machine and a menu full of ice cream and food are a long way from the real estate office which used to occupy the house with a scenic view of Kellogg Park.

It was part of the plan by Van Esley. And now it has materialized with the help of friend and fellow Plymouth Township resident, John Lis, into a cone zone with a distinct nod to the country's political and commercial history.

Public hearing date set for SEI industrial facilties exemption

A Sept. 10 public hearing for an industrial facilities exemption certificate, requested by SEI Automotive Technologies, was granted by the Plymouth Township Board of Trustees.

SEI, a subsidiary of Sumitomo Electric Industries, has planned to construct, own and operate a new technical center on Polaris Court in Metro West Industrial Park.

The project that exemption is being sought for consists principally of a 40,000 square foot building, associated equipment and systems for security, design, development, production, engineering, prototype manufacturing, testing and related activities directed initially towards brake pad materials, brake pads and calipers for brake systems.

The combined cost of the new facility is estimated at \$7,656,000. "It's a five acre site with a 40,000 square foot building that will be able to be expanded by 10 and 20,000 square feet in the future. The floor plan hasn't really been worked out yet," said SEI's Roger Cummings.

The project is expected to initially employ approximately 25 people, with the number increasing to approximately 45 people by the end of the second year of operation. Half of the workers will be employed by SEI's affiliate, Sumitomo Electric Wiring Systems (SEWS).

SEWS, a Kentucky-headquartered manufacturer of electrical wiring harnesses and components, plans on using its balance of the building as a technical center also.



Soon after The Crier published a photo editorial on the state of the former Amoco gas station at the corner of Ann Arbor Trail and Main Street, we received

a visit from Kent Barry, the senior public relations man for Amoco's Midwest region.

From what Barry said, Amoco is even more anxious than the community to use or sell the property.

There's one major problem preventing them from doing anything with the property: The soil remains polluted with gasoline. The state won't let the property be developed or sold until it's cleaned up.

"We've worked with the Plymouth Chamber of Commerce and the residents to come up with solutions," said Barry. "It remains an ongoing project."

So who's to blame? Where should we light the fire to get this piece of land cleaned up?

Some of the blame goes to Amoco. Barry said the company doesn't deny that gasoline pollution is the cause of the contamination. But it's not all Amoco's fault. "We've spent a huge amount of money to clean this site up already," Barry said. "We have an economic incentive to clean up the site. We know the important role that piece of land plays for the community. We're doing this as quickly as possible, sparing no

expense."

He's right. Amoco has spent thousands and thousands of dollars on the Plymouth site. They've had sites that cost well over \$1 million to clean up.

And it's happening around the state. Amoco and other oil companies are scrambling to clean up old gas station sites. It's not easy work.

And they're not getting much help from the state. Once a site is in remediation, the bureaucratic red tape usually strangles any progress. So part of the blame goes to the state.

But let's not forget that it's our thirst for gasoline that brought the gas station to town in the first place.

It's time for a solution to the gasoline contamination problems. Community residents, the State of Michigan and oil company representatives need to come together to find answers.

Quick clean-up is critical. Land in downtown Plymouth is far too important to sit vacant.

According to Barry, it may be several more years before the Amoco station is cleaned up in downtown Plymouth.

Until a broad solution is found to clean up the many contaminated sites across the state and country, we're all losers

"Historical events occur twice: the first as tragedy, the second as farce." The July 31, 1985 edition of The Community Crier questions the future of educational awareness and civic responsibility in The Plymouth-Canton Community.

On that date, a two-page editorial ran, listing the 1,719 citizens who had voted in that recent school board election. An unconcerned 96.33 per cent of the then 46,860 registered voters in the district chose not to use their inalienable right. "Voter apathy has reached an all-time embarrassment in The Plymouth-Canton Community" the first sentence of that editorial

That was wrong. This June 10, just 2,182 citizens had cast their ballots a less than three per cent voter turnout.

So 2.87 per cent of the Plymouth-Canton School District voting population made the decision for all the now 62,578 registered voters — 60,396 people stayed home, a figure more than the entire population of Canton.

Why devote the space around this editorial to honor all the civic-minded

citizens who voted on June 10? To demonstrate the issue! Imagine: the names of everyone who voted in Michigan's eighth largest school district fits onto two full-pages - again.

(Note that the names of some so-called community leaders and constant complainers do not appear here. They didn't vote.)

It's obvious the time has arrived to cancel any and all school elections.

Let the school board sort it out without costly citizen input (a.k.a. elections). Let the school district keep the money it costs to hold a regular election — \$13,111, the district says — plus the expense of keeping voter rolls up to date and the cost of buying, storing and maintaining voting equipment.





Better use of existing classrooms needed, not new district schools

EDITOR:

We are in the middle of summer. Our kids are home with nothing to do. Their schools are empty except for a few maintenance workers who fix the occasional leaky roof. Their teachers and administrators are relaxing at their northern cottages or just puttering around the house.

The voices that demand more tax money for more school buildings are quiet. This fall, when those voices rise again, let's not forget these lazy days of summer when the school buildings sat empty. In fact, our public school buildings are often empty. When you compare the current 181 day school year to the total number of normal working days in a year (250), we can see that we're only using 72 percent of our classroom capacity. In a competitive business environment, we would not consider investing in additional buildings when the existing ones are only used 72 percent of the time.

The "boom" in the projected student population of Plymouth-Canton Schools is a temporary result of rapid growth in new housing in Canton and the fact that the children of the "Baby Boom" generation are moving through the system.

Let's not find ourselves in a few years like some of our neighboring cities who are closing schools while still paying off the bonds that built them. Let's give serious consideration to using the existing buildings yearround until the "boom" subsides.

Our children will already be paying for the multi-million dollar technology bonds that give us big screen T.V.'s (that rarely work) hanging from the ceilings of every classroom and lots of computers that are already obsolete. Let's not also saddle the next generation with boarded up school buildings and even higher taxes.

The additional costs of keeping the existing schools open year-round is far less than the cost of building new schools and hiring the additional staff needed to run them. Let's make better use of our existing classroom, administration and teaching resources before asking taxpayers for more money.

I would like to correct a few points made in your introduction to the school board candidates article (April 10, 1996).



The Hilltop Junior Golf Tournament will be taking place a week from today at the Hilltop Golf Course on the corner of Ann Arbor Trail and Beck Road.




In the boys 10 years and under division, Michael Ware defeated Phillip Lake by the scores of 6-1, 6-1.

Take your chip of public courses

Despite the opening of the highly touted Pheasant Run Golf Course, the two other government owned courses in the area — Hilltop and Fellows Creek — seem to have not been greatly affected.

It's been a year since the Pheasant Run course at the Summit on the Park began catering to golfers of all skill levels, and the public response has been very good, if not great. Fellows Creek, also in Canton, and Hilltop in Plymouth, know their courses may not be as competitive as Pheasant Run. But they think they offer a lot to the Canton resident golfers, and have dealt with their Pheasant's opening pretty smoothly.

Pheasant Run, along with the Summit building, has become a main attraction to residents of Canton and non-residents alike

"We've had a really good response and we're doing approximately how we expected," said Paul Simpson, the Pheasant Run assistant golf professional. "Word is getting around the area about the course and business continues to pick up."

Everything has been up and running since the beginning of the year when the grill was opened, the final piece of the Pheasant Run puzzle being put in place.

Meanwhile, Hilltop has gone through some changes in the last year as American Golf took over the lease and operations on February 27. Their general manager and superintendent positions were replaced and renovations and upkeeping have been ongoing.

"We haven't been open long enough to tell the effect (of Pheasant's opening)," said Hilltop General Manager Paula Ball, "but we have been improving and providing quality customer service."

Hilltop's new management has been

running long enough to begin work on new cart paths, tee markers, ball washers, new bunkers and drainage.

Fellows Creek is a course that's been chugging along without any changes in the last 10 years, and even with the opening of Pheasant Run, Course Supervisor Steve Mayo said that on a day-to-day basis, nothing has changed.

"Right now I don't think we're in the same arena in quality of courses as they (Pheasant Run) are," Mayo said. "We're not the same type of course. We like to give the average golfer the country club feel, so I think we're here for the average Canton resident."

One of the main reasons the effect of Pheasant's opening has been minimal is the fact that Fellows Creek and Hilltop holds leagues from Monday to Friday every week.

Meanwhile, Pheasant Run wants to provide open tee time for non-league golfers.
