John Dillon Lashes Britons

"Not since the days of the Romans, said John Dillon (Irish nationalist) in the debate on the address in reply the king's speech at the opening parliament, "has an army made a habit of capturing women and children as the British generals in South Africa

are doing." This, Mr. Dillon added, was cruel and cowardly. To put Boer women on half rations because their husbands had not surrendered, as was the unde-nied practice in the reconcentrado had not surrendered, as was the unus-nied practice in the reconcentrado camps, was worthy of the worst bri-gands of Sicily and Greece, This plan of starving women and children had been adopted by the war secretary, Mr. Broderick. Mr. Dillon congratulated the Boers on having a different

Mr. Broderick replied that the British conduct was humane. It was not true that the country had been devastrue that the country had been devas-tated deliberately and by whol sale. Farmhouses had been burned for cause, and portions of the country had been devastated because it had been fought over five or six times. In cases the Boers deserted their houses kamrs burned them.

Mr.Dillon offered an amendment objecting to house burning and the im-prisonment of women and children, which was rejected by 91 to 243 votes. The reply to the king's speech was adopted by 297 to 78 votes.

ORIGIN OF THE MORGAN BEAL.

Big Steel Trust the Datcome New York, Feb. 28.—The Time

Times says New York, Feb. 25.—The times say that after having maintained silence on the subject of the raw steel combination for many weeks, J. Pierpon Morgan, while in his office, said, after Morgan, while in his office, said, after he had read an article in a Boston paper entitled "The United States Ste-Corporation—A Unification of Great interests," "that is the best statement of the situation that has yet comto my notice. Had I written it myseM I could not have stated the situation better.'

The article makes the following statement, which is the first authen-tic admission of the questions which brought the consolidation about: "Andrew Carnegie recently threatened to duplicate the mills of various makers of finished productions because enough raw material was not being purchased from his mills. The companies mak-ing the finished productions threatened retaliation into the Carnegie field, with the result that a sort of industrial chaos was threatening in the steel and fron trade and in .the security mar kets of this country."

How Mr. Morgan was brought the matter is stated as follows: was brought into Carnegie said he must progress or go out of business. Other interests said they must do the same thing. Mr. J. P. Morgan was asked to furnish some plan of solution. With great reluctance he took hold of the situation Before proceeding, however, Mr. Morgan demanded that \$200,000,000 should be promised him by responsible banking and financial interests, should a much money be needed. The money was promised and Mr. Morgan set to work. Mr. Carnegie had the la plant and the strongest position named his terms of sale. He, however, signified his willingness to take securiproceeded very rapidly."

OLDEST FRAGMENT OF GOSPEL

Dr. Winslow Announces Discovery of Par

of First Chapter of Matthew.

Boston, Mass., Feb. 28.—The Rev.

Dr. William C. Winslow of this city, vice president of the Egypt exploration fund, today announced the discovery of a most valuable trophy among the large number of papyri recently re-ceived by Dr. Winslow for distribution among several universities, twenty nine of which went to the University of Pennsylvania. It is the oldest fragment of the gospels of the world nov in this country. Dr. Winslow states that papyrus contains a large part of the first chapter of the gospel of St Matthew. It was found at Oxyrhynchus, 140 miles south of Cairo, near the famous "Logia," or "Sayings of Jesus," and its date is placed by some experts at 150 A. D., and by editors of the societies' publication at fifty or

sixty years later.

This papyrus of St. Matthew belongs to the same class as the famous Sinaitic and Vatican codices, and, of course, is a remarkable corroboration of those and the present accepted ve On an important doctrinal point it de clares in common the exact language: "Joseph, thou son of David, fear not take unto thee Mary, thy wife, for that which is conceived in her is of the Holy Ghost." This papyrus is the odest fragment of the gospels, or, inest fragment of the gospe deed, of the new testament.

Dr. Winslow states that valuable papyri of Homer, Thucydides and Euclid also are in the collection. The papyrus of Thucydides includes no less then chapters 36 to 41 of his fourth book, eight dates from the first century

#### CUBA AND PHILIPPINE NEWS.

After a discussion of several hours on the 25th, the constitutional convention adopted an article defining the proposed relations, namely, that Cuba would not make treaties with any country which would endanger the sovereignty of the republic or allow the island to be made a base of war treattions against the United States. the island to be made a base of war operations against the United States or any other country. The last four words, 'or any other country," were added after a warm debate. The advocates of the clause maintained that Cuba should remain peutral, as a war carried on in the island would only result in the ruin of its agricultural interests, which had already suffered greatly and had not yet fully recovered.

Licut West, with a detachment of
the crew of the gunboat Laguna de
Bay, attacked 200 insurgents under,
Caballos, near Vacinta, province of
Laguna. After a fight of 40 minutes
the insurgents were dispersed, losing
6 killed and 14 captured. A detachment of the 47th volunteer infantry,
encountered a body of insurgents in
the province of Amboy, killing 18, and
subsequently another body, killing 9.
The Americans had no casualties. A
squad of the 18th U. S. infantry surprised a band of Ladrones, at Moosin,
Island of Panny, killing 6 and capturing 5 rifles. ing 5 rifles.

Gen. Gomez visited Gov.-Gen. Wood on the 26th, and assured him that the stories of unrest and dissatisfaction at the continuance of the U.S. interven-tion were false and that he had been tion were false and that he had been misrepresented in statements to the effect that he favored an immediate withdrawal of the U. S. troops and giving Cuba absolute independence. If they withdrew now he feared bloodshed. Beyond doubt, within 60 days the Cubans would be fighting among thomselves. themselves.

Capt. Lowe, with a detachment of the 25th regiment, has captured a ladione camp in the mountains of Nueva Ecija and killed the leader, the notori-ous Angel Miranda. Lieut. Lewis, with a detachment of the 3d infantry, has had five skirmishes with the insurgents in the Panpanga swamps. The enemy were routed and 16 rifles were secured.

Chaplain Fitzgerald administered the oath of allegiance to 200 Ilocanos at a church in Vigan, Feb. 22, and a parish priest at Santa Catalina administered a similar oath to 700 natives Feb. 24.

The transport Solace arrived at San Francisco on the 24th from Manita with 6 officers and 17 privates sick and wounded. She also brought 13 military prisoners.

Gens. MacArthur. Wheaton and Young reviewed the 33d and 34th regiments on the 26th. The troops presented a splendid appearance.





The people who read newspapers and magazines have as a rule, a belief that publishers have no conscience about oading up their periodicals with adver isements at the cost of reading matter. Yet occasionally some proof comes to the surface that publishers have some scruples in this respect. The Ladies' Home Journal, for example, will accept jnst so many columns of advertisements and no more. This proportion, for in stance, is 70 columns of advertisements as against 122 columns of reading matter in each issue of 48 pages. When the advertising space is full all business s declined. The skeptical may ask But is there any business left to decline?" There is, decidedly. For nearly every issue during 1900 there were from four to twenty-six more columns of de-sirable advertising received than could be accepted, and as each column in the Journal costs \$1000 the publishers turued away thousands of dollars, which simply because of principle, they would not accept. So the interests of the public are sometimes regarded where they are hot popularly supposed to be.

Not content with the hanging, draw. Not content with the nanging, the crowd cut the corpse down, and, laying it on a sand bar under the bridge, kindled a fire and cremated the remains. Intense excitement followed. Several points of order were made by Republicans, but the speaker declined to sidstrack the matter, in that way, holding, however, that to proceed a proposition of some kind must be before the house.
