Good review

Plymouth city officials were pleased to see the results of a third-party study they say in nearly every way validated the city's decision to partner with the city of Northville for fire services last

The 51-page report, "Service Model Review and Analysis," released by the International City/County Management Association **Center for Public Safety** Management, featured a thorough analysis of 2012 Plymouth city fire services during the first calendar year of the partnership.

"The city of Plymouth has created a successful public safety service delivery model that is efficient (reduced expenditures for fire and emergency medical services) and effective (increase in the capacity of the firefighting force and responding equipment; the EMS service; and enhancement of police services) through the integration of three key agencies — the city of Plymouth Police Department, Huron Valley Ambulance and the city of Northville Fire Department," the report read.

The partnership, Plymouth officials said, saves the city some \$400,000 a year.

District benefits from budget boost

Like leaders in other school districts, administrators and the Board of Education in Plymouth-Canton Community Schools are in the middle of putting together their 2013-14 school year budget.

If the plan approved Tuesday by the state House of Representatives makes it to Gov. Rick Snyder's desk, they'll have more money to work with.

The budget approved by the

House includes, among other things, an increase of some \$443 million for schools and will hike Plymouth-Canton's total state foundation grant to \$7,191 per pupil, an increase of a little more than \$1 million overall.

"The one thing the board is interested in is, 'How does this news look compared to what we've been talking about in our budget projections?" Brodie Killian said. "From what we originally had been talking, it leaves us better off."

The district likely will qualify for other funding from the state as well. Killian said the district expects to get some \$52 per student for best practices such as consolidating services, and some \$70 for district performance (measuring things like student test scores).

The budget also pays some \$100 million on the teacher retirement fund debt (debt that has to be paid by both the state and local districts).

State Rep. Kurt Heise, R-Plym-

outh Township, who has voted against the last couple of Snyder's education budgets, said this one was a budget he could get

"For me this represented a real increase for Plymouth-Canton schools," Heise said. "The last two budgets were pure cuts to our bottom line. This budget in no way fully restores the cuts of the last two years, but it's a step in the right direction."

Split town board OKs \$35,000 fireworks show

More than 5,000 shells will light up the sky over Hilltop Golf Course during Plymouth Township's Independence Day fireworks show this sum-

Amid questions about pro-

cedure, the township Board of Trustees approved Tuesday a \$35,000 contract for the show with a Pennsylvania-based fireworks company. The deal is contingent upon raising the required cash through sponsorships and donations. Treasurer Ron Edwards, who is in charge of fireworks fundraising, said he expects to meet the goal.

The fireworks are scheduled for Wednesday, July 3, with a rain date of Friday, July 5. The public viewing area is at Plymouth Township Park.

Tuesday's board vote was 6-1, with Trustee Chuck Curmi the only dissenting vote.

But Trustee Bob Doroshewitz questioned whether the township should seek bids for the show instead of again awarding it to Zambelli Fireworks Manufacturing Co. Township policy generally requires bids to be submitted for purchases and contracts, except for professional services such as legal work, that total more than \$15,000.

"Our own board policy requires we get three bids," Doroshewitz said. "We're not following our own policy if we approve

Edwards responded that Zambelli is the preferred company because it offered liability insurance — up to \$10 million — that other companies couldn't match in 2008, when the township started with Zambelli. The board can choose when to deviate from its policy, he said.

"Fireworks are hazardous. They can go bad, and we're getting a national company for them," Edwards said.

In a voice vote, Doroshewitz and Edwards voted for the contract, along with Supervisor Rich-

Curmi said after the vote that while the fireworks event is a good one, it's not the township's place to organize it.

"I just don't think it's a township function," Curmi said. "I'd like to see a nonprofit doing it."

Reaume responded Wednesday that a nonprofit had organized the fireworks show years ago, but had trouble raising enough money and dropped it. The township revived the fireworks with the 2008 show.

"That's the reason we took it back over, is that there were going to be no fireworks," Reaume said.

Reaume added that local government has more resources to plan such an event and to ensure public safety, and perhaps has relationships with local companies that allow it to land bigger sponsorship donations.

According to the township's contract with Zambelli, the show will include fireworks display shells ranging from one inch to 10 inches in size, including more than 2,000 one-inch shells, 1,680 three-inch shells and 690 four-inch shells.







Plymouth store survives ACO purge

ACO's decision to close 14 underperforming stores will not affect its Plymouth location.

ACO officials announced the chain will close the stores as part of a "planned course of action to improve and strengthen the company's financial performance." The store in Canton, located at 43335 Joy, is one of the stores being closed.

ACO's decision won't affect the Plymouth location, where an interior redecoration and expansion was completed last year that brought it from about 8,000 to about 15,000 square feet and gave customers more space, better lighting and a wider range of products.

"We knew this area needed a bigger and better store," Janet Mahy, ACO Hardware's general merchandising manager, said at the time.

Other stores weren't as lucky when the Farmington Hills-based chain

announced its revamping this week. "The plan we are announcing is one we are enacting following a thorough evaluation of our operations," said president and CEO Dick Snyder. "To ensure our long term growth and sustainability, we must always strive to manage our costs and allocate resources to areas of our business that make financial performance. This plan keeps us on that course. It will ultimately strengthen our position within the marketplace. It gives us the ability to redirect investment to the stores that offer the greatest potential for development, and the flexibility to pursue new opportunities as they arise."

Officials said ACO is already seeing positive results of new initiatives under the plan. The company is in the process of remodeling stores to make shopping easier, and to showcase the wide variety of hardware, home and garden products they offer. They have also recently begun new advertising and marketing efforts designed to spotlight the remodeled stores and expanded merchandise selection.

Over the next several weeks, ACO will conduct a "Total Inventory Blowout Sale" of the inventory in each of the affected locations.

At this time, an actual closing date for each store has not been determined.

State Rep. Dian Slavens, D-Canton, disagreed, calling the additional money that will actually go into the classroom "disappointing." According to Slavens, when the money that will go toward retirement debt is factored in, only \$19 per student will actually go into the classroom. That's why, she said, she voted against the bill.

"We have to make sure we're investing in education. ... That should be our number one priority," Slavens said. "There are extra dollars we should have put into the school aid fund, and they chose not to. That's unfortunate for our schools."

Killian pointed out that, while the state may be upping the foundation allowance, it is


also changing the formula by which it is paid out. In the past, 10 percent of the budget has been based on the previous February's student count, with 90 percent on the October head count. Under the new plan, Killian said, 90 percent will be based on this fall's count, with the other 10 percent based on next February's count.


Because the district generally loses "about 80 or 90 students" in the spring, Killian said, the district could be working with some \$600,000 less.

"It helps, but a \$1 increase in the (state) money doesn't necessarily translate to \$1 to spend on students," Killian said. "A lot of these (new funds) are one-time things. It doesn't necessarily mean it's always going to be there."

Shooting suspect expected to be arraigned today

A man accused of shooting another man Tuesday morning on Livonia's east side is expected to be arraigned on charges today in 16th District Court.

The victim was taken to an area hospital where he is being treated for the gunshot wound. His injuries are not lifethreatening. No other details regarding the case were released by Livonia police.

Alcohol stolen

Alcoholic beverages were taken in two apparent shopliftings in Plymouth Township last week, police report.

locate a man fitting the description the employee provided, a police report said. It was not known what kind of beer had been taken.


A few hours later, Canton veterans, leaders and residents gathered for that community's traditionally understated, but dignified, Memorial Day ceremony in Heritage Park.

McCotter staffer pleads no contest in petition signature scandal

One of former U.S. Rep. Thaddeus McCotter's staffers has pleaded no contest in the petition signature scandal involving his office last summer.

Mary Turnbull, a Howell resident and McCotter's former district representative, pleaded no contest Tuesday to the charge of conspiracy to commit a legal act in an illegal manner before Oakland County Circuit Judge Leo Bowman in Pontiac.

Turnbull was accused of being one of four staffers on the former Livonia congressman's campaign involved in illegally copying signatures for petitions to put McCotter on the ballot. After the signatures were found to be invalid, McCotter said

Turnbull is scheduled to be sentenced July 9. She faces a maximum of up to five years in prison.

McCotter was replaced by Democrat David Curson of Belleville for about six weeks after the November election in the 11th District before redistricting took place earlier this year. The current representative for the district is Milford resident Kerry Bentivolio, who originally filed to run against McCotter in the GOP primary last summer.

Turnbull's case is the second to be resolved after McCotter resigned last summer. Another former staffer, Livonia resident Lorianne O'Brady, was sentenced to 20 days in jail or 20 days in a work-release program after she pleaded guilty to five counts of falsely signing a nomination petition as a circulator, all misdemean-

Two other staffers, Paul Seewald and Don Yowchaung, continue to face charges in the state court system. Both were originally charged with conspiracy to commit a legal act in an illegal manner, but both had those charges dropped by Wayne County Circuit Judge Margie Braxton. The Michigan attorney general's office is currently appealing the decision to the state Court of Appeals.

McCotter was subpoenaed in the pair's preliminary examination in Livonia's 16th District Court last fall. He was not charged with any crimes involving the falsified signatures.

Both also were charged with several counts of falsely signing a nomination petition as a circulator last fall. Both were sentenced to probation.

read a story about grandparents from Michigan who lost more than \$30,000 in a scam that involved someone posing as their grandson. The caller asked them for cash to help pay a fine and to post a bond to get him out of a Canadian jail. They sent the money, but it turned out to be a scam and they lost a substantial portion of their savings.

I have written about other scams targeted at grandparents, but I thought I would do it again because these types of scams are becoming more common.

The scam that is very common today is where grandparents receive a call from someone who is impersonating their grandchild seeking an immediate transfer of money to help them out of a crisis situation. Think back four or five years ago and there were less than 1,000 of these types

10,000 of these scams reported just last year. In addition, we all know the reality and that is that a lot more of these frauds are occurring, but people aren't reporting them. The problem has become epidemic, so you need to know how to prevent them from happening to

Scam elements

The grandparent scams contain two elements that help people perpetuate the fraud. The first is the need for immediate money in order to resolve a crisis situation. The monev could be used for medical costs, to pay a ticket or fine or to post a bond to get out of jail. The

common element is there recognize there are legitis an emergency The other element to the scam is the need

for secrecy. The caller who is impersonating a grandchild convinces the grandparent that his/her parents cannot be notified. These scam artists are good and they know how to illicit information from the unsuspecting grandparent. In fact, this scam has become so prevalent that Western Union has put a warning on its forms advising against sending money for unconfirmed emergency situations. In addition, they are training agents to look out for these types of scams.

Verify information

Grandparents have a soft spot in their hearts for their grandchildren. The scam artists know this and they attempt to exploit it.

How can you guard against this happening to you? Make sure to independently confirm that an emergency exists. I

imate cases where grandchildren want to keep things from their parents, however, when you're asked to send money, red flags should go up. Get more information before you send any money.

It's unfortunate that we constantly have to keep our guard up and be aware of low-lifes out there that want to take advantage of us. That is the reality of the situation. What is also reality is that many of these scam artists, because of the Internet, can find out all sorts of information about us and our families and are willing to exploit it.

The bottom line, we have to be smarter than them. Taking a few minutes to confirm an emergency will go a long way in protecting yourself. Good luck!



Be prepared for traffic delays as road construction season gets into full swing. Here are a few planned area road construction projects to watch for in Plymouth/Plymouth Township, Farmington/ Farmington Hills and Livonia throughout the spring and summer.

Plymouth/Plymouth Township

The mile-long stretch of Haggerty Road between Plymouth Road and Schoolcraft is under construction for the next three months.

The road is undergoing an asphalt resurfacing in the area near Plymouth Road, a reconstruction in concrete in the area near Schoolcraft and a reconfiguration of the intersections at both Plymouth and Schoolcraft roads, according to Plymouth Township and Wayne County officials.

The \$1.12 million project is expected to be completed at the end of September, said Patrick Dostine, public information officer for the county's Department of Public Services. Drivers can expect lane closures, but traffic is expected to be maintained on Haggerty for the duration of the work, Dostine said.

Improvements are planned at both the Schoolcraft and Plymouth road intersections, including, at Schoolcraft, the introduction of a "Michigan left," or turnaround, system for making left turns and, at Plymouth, better lane def-

The Haggerty project is one of several planned for county roads in Plymouth Township this year:

• In June, the decks of two Hines Drive bridges over the Rouge River, just west of Haggerty in Hines Park, are scheduled to be resurfaced. The bridges will be completely closed and a detour is planned.

 Sheldon Road between M-14 and Five Mile is scheduled to be resurfaced in asphalt beginning in August; that project also includes a new traffic light at Sheldon and Plymouth Oaks Boulevard. Lane closures can be expected, but no full road closures.

Farmington/Farmington Hills

 Two special assessment districts in the Staman Acres and Stratton Hills neighborhoods for road rehabilitation, including repaving. Staman Acres is between Power and Orchard Lake, north of 10 Mile. Stratton Hills is east of Drake, between 13 and 14 Mile roads. The road rehabilitation portion of the projects tops an estimated \$4.8 million of which the city's 20 percent share is

• Freedom Road, just west of Drake to the city limits. This is federal aid project include road resurfacing and drainage improvements.

• 13 Mile Road between Middlebelt and Orchard Lake. The project will include removing the existing pavement, creating a center left-turn lane and adding a sidewalk on the south side. The work is east of the Glen Oaks Golf Club. The improvements will allow the road to be used as a detour when work begins next year on construction of a roundabout at 14 Mile and Orchard

 Middlebelt Road near Hillel Day School, just north of 14 Mile. A smaller project, work will include construction of a right turn lane off Middlebelt in the school entrance area.

Oakland County also has two projects in Farmington Hills this season. They

 Resurfacing of 14 Mile, Haggerty to Country Way. The work is expected to begin after July 4 and be completed in November.

 Grove Street. The existing roadway has already been removed, from Grand River to Orchard, as has a portion of the parking lot of the Grove Retail Center that abuts the roadway. Grove will become a boulevard with a center island and angle parking. The area will be landscaped and feature brick paver sidewalks. Water main replacement is included in the project.

 Warner and Oakland streets: The projects will include water main and road replacement. A one-eighth mile piece of Warner that connects Farmington's historic neighborhood to Grand River will receive a spruce up, including brick pavers, landscaping and lighting.

Livonia

Crews will patch concrete in eastbound and westbound lanes of 5.7 miles of Schoolcraft Road in Livonia from mid August to early September in preparation for the I-96 shutdown next year. Schoolcraft will have only one lane open for motorists next year while construction on the freeway and bridge overpasses is completed. One lane will be used by contractors to move trucks and construction vehicles around the various sites on I-96 and the overpasses.





Family, friends welcome new priests

Local residents were among three men ordained May 18 into the Catholic priesthood.

The Most Rev. Allen H. Vigneron, archbishop of Detroit, celebrated the Mass and the Rite of Ordination at the Cathedral of the Most Blessed Sacrament which welcomed the Rev. James Grau of Livonia, the Rev. Marko Djonovic of Farmington Hills and the Rev. Patrick Gonyeau of Harper Woods as priests of the Roman Catholic Church.

The Rite of Ordination is what "makes" one a priest and takes place within the context of the Catholic Mass. The bishop lays his hands upon each candidate (followed by all priests present), before offering the consecratory prayer, invoking the power of the Holy Spirit upon those being ordained.

Following the ordination, a reception was held on the grounds of the cathedral. The next day, each new priest said his first Mass and then gathered with well-wishers to

celebrate. Here are some highlights of the solemn occasion from the two local men who were ordained and their families and friends.

Rev. James Grau

As a kid, priesthood was "definitely one of several things" that Grau considered.

"It wasn't really until college that I knew I wanted to be a priest,"

said Grau, 28, who graduated in 2000 from St. Michael the Archangel Catholic School in Livonia. His mother, Julie Grau, credits the Felician sisters at the school for their dedication in helping to foster her son's Catholic education.

In 2004, Grau graduated from the University of Detroit Jesuit High School. After graduation, he attended Sacred Heart Major Seminary in Detroit and then transferred to the North American College in Rome, where he is currently earning the equivalent of a master's degree (called a "licentiate") in biblical theology. "To be chosen to study in Rome is a great honor," said the Rev. William Tindall, pastor of St. Michael Catholic Church. "The decision is based on the student's academic abilities, his spiritual development and his level of maturity."

Last Sunday, the St. Michael's family welcomed Grau back to his home parish.

"It was pretty incredible celebrating Mass at St. Michael's - somewhere that I was very familiar with, where I grew up," said Grau, who lived in Livonia for 23

"It is always an hon-

or for a parish when one of its own is ordained to the priesthood. It is also an honor for his family, because vocations are most often grounded in the faith and love of a family. Everything about (his first) Mass spoke to the faith of those present and the faith that motivated Jim to serve the church," Tindall said.

Therese Marshall of Livonia lives next door to the Grau family. She remembers "Jimmy" as "rather reserved with that infectious grin. He was polite, playful and respectful - took his older brother role seriously, maybe the precursor of developing that 'fatherhood role' he spoke of at his reception.



AN ORDINANCE TO AMEND WAYNE CITY CODE BY ADDING CHAPTER 692, SECTIONS 692.01, 692.02, 692.03, 692.04 AND 692.99 DEFINING FIREWORKS, GOVERNING THE USE OF FIREWORKS, AND PROVIDING PENALTIES FOR A VIOLATION

CHAPTER 692 - FIREWORKS

692.01 - Definitions

- For purposes of this section, the following definitions apply:
- Act means the Michigan Fireworks Safety Act, MCL 28.451 et seq., as that statute may be amended from time to time, which is hereby adopted by reference as part of the ordinance
- Agricultural and wildlife fireworks means fireworks devices distributed to farmers, ranchers, and growers through a wildlife management program administered by the United States Department of the Interior or the department of natural resources of this state.
- Articles pyrotechnic means pyrotechnic devices for professional use that are similar to consumer fireworks in chemical composition and construction but not intended for consumer use, that meet the weight limits for consumer fireworks but are not labeled as such, and that are classified as UN0431 or UN0432 under 49 CFR 172.101. Consumer fireworks means fireworks devices that are designed to produce visible effects
- by combustion, that are required to comply with the construction, chemical composition, and labeling regulations promulgated by the United States Consumer Product Safety Commission under 16 CFR parts 1500 and 1507, and that are listed in APA standard 87-1, 3.1.2, 3.1.3, or 3.5. Consumer fireworks do not include low-impact fireworks.
- Display fireworks means large fireworks devices that are explosive materials intended for use in fireworks displays and designed to produce visible or audible effects by combustion, deflagration, or detonation, as provided in 27 CFR 555.11, 49 CFR 172, and APA standard
- Fireworks or fireworks means any composition or device, except for a starting pistol, a flare gun, or a flare, designed for the purpose of producing a visible or audible effect by combustion, deflagration, or detonation. Fireworks consist of consumer fireworks, low-impact fireworks, articles pyrotechnic, display fireworks, and special effects.
- Low-impact fireworks means ground and handheld sparkling devices as that phrase is defined under APA standard 87-1, 3.1, 3.1.1 to 3.1.1.8, and 3.5.
- Novelties means that term as defined under APA standard 87-1, 3.2, 3.2.1, 3.2.2, 3.2.3, 3.2.4, and 3.2.5 and all of the following:
- Toy plastic or paper caps for toy pistols in sheets, strips, rolls, or individual caps containing not more than .25 of a grain of explosive content per cap, in packages labeled to indicate the maximum explosive content per cap
- Toy pistols, toy cannons, toy canes, toy trick noisemakers, and toy guns in which toy caps as described in subparagraph (1) are used, that are constructed so that the hand cannot come in contact with the cap when in place for the explosion, and that are not designed to break apart or be separated so as to form a missile by the explosion.
- Flitter sparklers in paper tubes not exceeding one-eighth-inch in diameter.
- Toy snakes not containing mercury, if packed in cardboard boxes with not more than 12 pieces per box for retail sale and if the manufacturer's name and the quantity contained in each box are printed on the box; and toy smoke devices.
- Special effects means a combination of chemical elements or chemical compounds capable of burning independently of the oxygen of the atmosphere and designed and intended to produce an audible, visual, mechanical, or thermal effect as an integral part of a motion picture, radio, television, theatrical, or opera production or live entertainment.

But it's also easy to understand the flip side; moreover, they shouldn't

The issue came up last week at the Board of Education meeting when several respected teachers and even more students stepped up during the citizen comments portion of the meeting to urge the school board not to cut the number of teachers they use to staff the writing centers.

Currently, there is one writing center staffed by one teacher for one hour at each school. Those three writing centers, in the first semester of the 2012-2013 school year (according to statistics provided by the district) conducted more than 1,200 "peer editing" sessions. The centers are an extension of the Honors Composition course and serviced not only by a teacher, but by student tutors.

Because class sizes are creeping up elsewhere and enrollment in Honors Composition is declining, the administration has decided for the 2013-2014 school year to cut it back to one teacher for one hour at Salem High School. Administrators correctly point out the service will still be there, "students will just have to walk to Salem to take advantage of it," and believe the single writing center can serve just as many students.

On the surface, a good point. But practically speaking, between moving between three different high schools and trying to get to other classes, how many students are going to be disenfranchised from the center? It's a good bet that number will be high.

But that's not even the point. The

biggest point was made by teachers, who correctly say writing is becoming an even larger part — if that's possible — of what students need to do to get through high school these days. It cuts across every thread of curricular activity at the high school level. The Plymouth-Canton Educational Park's own school improvement plan calls for an improvement in writing skills.

Board members' reaction to the news — they said it was news to them — raised a few eyebrows. Supt. Dr. Jeremy Hughes fell on the sword by saving it was definitely not a board decision. But the board's lack of knowledge is surprising given

their general level of micro-managing the administration.

Administrators are right; these are very hard decisions in very difficult times. The board's absolutely proper desire to keep class size to a minimum and uncertain state funding leaves them firmly between a rock and a hard place.

The teachers who set up the writing center a decade ago heard from colleges and universities with similar programs that students react far better to peer editing than to teacher review. They set up the writing center to reflect that research.

To this point, the district has done a remarkable job of keeping cuts to the classroom at an absolute minimum. If student achievement really is the goal, they should keep this cut out of the classroom,

tion of being the very first road in this nation that was paved with concrete. The citizens of this state had the foresight to be among the most progressive in the country on



transportation issues. Dirt and wood planks were not appropriate for a community looking into the future. My, how times have changed.

Instead of leading the way on road infrastructure issues in the nation, Michigan is at the bottom of the pile. Michigan spends much less on its roads than virtually any other state in the nation. In the past, the legislature did not want to raise taxes to deal with road problems, so they borrowed money. The road projects were accomplished, but we are still paying for those projects today out of money that should be used to deal with today's issues.





Madonna softball coach White retires

Madonna University head softball coach Al White, a Canton resident. announced his retirement Tuesday after 15 seasons

at the helm of the Crusaders.

White ends his career with a 513-

266-4 record. An original member of the Madon-

na softball staff since the program's inception in 1992, White guided MU to five Wolverine-Hoosier Athletic Conference regular season championships and six WHAC tournament titles.

He was named the WHAC's Coach of the Year four times and his 513 wins are the most in WHAC history among softball coaches.

"It has been a long

time," White said. "My body just won't let me do what I used to do and so it's time. It's been fun, but it's over. I enjoyed my time here and I want to thank Ray Summers for believing in me when he hired me. The time commitment my staff put in was amazing. I can not thank them enough as well. My grand kids are getting older now and starting to play travel ball and now I can see them more."

White does not leave the cupboard bare as he had signed nearly a dozen players for next fall.

"The class we have coming in, I feel great about them," said White, who posted a 32-18 record this spring. "They are all great students and athletes. They could be one of the best ever and I'll put them right up there

with the class that had Jess Irwin, Tara LaMilza, Kelly Lesko and Ashley Shay in it. That group really put Madonna softball in the national light."

Under White's direction, the Crusaders advanced to the NAIA National Championship three times in the last five seasons.

White was inducted into the Amateur Softball Association Hall of Fame in 2011 for his playing career in men's modified fast pitch softball.

Meanwhile, the search for White's replacement is underway.

"We appreciate everything Al has done in building a nationally competitive program," MU athletic director Bryan Rizzo said. "He leaves big shoes to fill. We wish him well in his retirement."

Talent and tireless work ethic are helping Ray and Johnson race to the top of the Salem leader board. Yet both point to Gerlach's influence and encouragement for their strong sea-

"He (Gerlach) wants to win and he'll work all of us together. He wants us all competing and doing the best we can," Ray said. "Track is an individual sport when you're running. But you also have to have your team there to back you up and be there cheering for you.

"That's probably the biggest reason why we did so well this year, was because of each other." She gets no argument

from Johnson about that. "I think it (team camaraderie) really makes a difference," she added. "Now that we have Coach Dave and everything, he really helps out and orga-


The score remained 3zip at the half, thanks in large part to the acrobatic efforts of McNeil.





Automatic renewal of pact not a plus

Q: Our management company wants to enter into a five-year management agreement with our association with a renewal of five years automatic, if not terminated within a certain period. Do you think that is a good idea?

A: No. I think that the management agreement should not



necessarily provide an automatic renewal provision since many associations forget to monitor that provision, and a

five-years contract sounds too long for any property management company. There should always be, however, even in a five-year contract, an escape clause for the association to extricate itself from the agreement with or without cause. Moreover, the association's attorney should review any management contract before it is signed, and make sure that the attorney reviewing it is not "in bed" with the management company because of financial referrals.

O: Our property management company in our condominium says that it has a form to use for its contractors that it used in another project, and, that it will save us a lot of money in legal fees. I suspect you don't agree with that, but what is your opinion?

A: Every contract

that an association or other entity enters into should be tailored to that particular project. While there may be similar clauses used in each contract, it is imperative that the contract be explicit to the needs of the parties to that contract. It is a false economy for the association to think that it is saving money by a managing agent arguably practicing law and, at the same time, potentially causing the association to incur liability in a future contract dispute. The association should make sure that it has its attorney review any major contracts that it enters into, perhaps in a dollar amount in excess of \$5,000.00 plus, and, of course, the management contract itself. That clause might best be set forth in the management agreement with the association.


